



## Living with Covid PPE Bundles and PPE Emergency Provision Order Form (GP, ACCHS and GPRCs)

This order form is intended to supply approximately one month's supply of PPE per practitioner for:

- GPs, ACCHSs and GPRCs willing to manage COVID positive patients face-to-face, until 30 September 2022 **(please order under Section 1)**
- ACCHSs and rural and remote GPs willing to manage COVID positive patients virtually and respiratory patients face-to-face, where workforce capacity is limited AND the GP is serving the community for most or all health needs, until 30 September 2022 **(please order under Section 1)**
- GPs and GPRCs willing to support COVID positive people virtually, and respiratory patients face-to-face are eligible to access P2/N95 respirators and eye protection, until 30 September 2022 **(please order under Section 1(a))**

Please note you must not place an order for a practitioner if you have previously ordered PPE items for the same practitioner within the last 4 weeks.
