





#### **Current Status**

- De-identified information from WentWest and WSLHD are available in one single platform since March 2020
- New Agreement signed to include Statistical linkage key in both datasets (August 2020)
- Next steps
  - Working on Statistical Linkage Key configuration an security
  - Testing the sensitivity and specificity for the SLK
  - Availability of the information via secured shared platform



# Accessibility

- Internal: Following existing 'Data Request Process'
- External stakeholders: Submit request with protocol and statement of use for DGAC (for needs assessment, co-commissioning)
- Research and Publication will need ethics approval before requesting access to the information
- University: Needs WSLHD ethics approval along with University approval
- Data sits under the governance of Data Governance Advisory Council (DGAC)- joint custodianship of WentWest and WSPHN.
